In order to promote or distribute any Sk8Trip / ABEC 11 products via the Internet the following guidelines must be met at all times:

1. All new accounts must receive authorization from Sk8Trip / ABEC 11 prior to any online display of Sk8Trip / ABEC 11 products.
2. If your company is an existing dealer/distributor that already has Sk8Trip / ABEC 11 products online, each site must be listed & approved by Sk8Trip / ABEC 11 before any new orders will be filled.
3. Each retailer must have proof of secure site certification from reputable outlet on the website.
4. All current & correct logos must appear on the retailer's online homepage and be approved by Sk8Trip / ABEC 11 before going live.
5. **Retailers must maintain MSRP or MAP pricing for current product unless authorized by Sk8Trip.**
6. **MAP, Minimum Advertised Price, is agreed to be set at a 5% maximum discount for all current ABEC 11 products.**
7. All Sk8Trip / ABEC 11 products must not be advertised online as being "on sale." The terms "on sale," "close-out," etc. must never be used in conjunction with the description of our products online, unless authorized by Sk8Trip / ABEC 11.
8. Absolutely NO sales are allowed through any other Internet outlet other than your approved shop website. NO eBay.com, Overstock.com, Amazon.com, etc. may be used unless authorized by Sk8Trip / ABEC 11. If authorized, it must also follow all guidelines.
9. Internet retailers must meet the conditions outlined in this Internet Agreement before approval. If any of these conditions are not met or broken at any time, the account will be terminated.
